DODO SFOA GENERAL TERMS AND CONDITIONS

1. ABOUT THE POLICY

Dodo Australia has developed this Acceptable Use Policy to ensure that each subscriber's use of the Service:

- meets legal requirements;
- does not unreasonably interfere with other subscribers; and
- does not unreasonably impact.

In this document, the following words have these meanings:

You means a subscriber to the Service, or any person who accesses the Service using the subscriber's access details;

Policy means this document, as may be amended by Dodo Australia from time to time on 14 days notice;

Service means a web hosting service provided by Dodo Australia, together with associated services and software such as email facilities, web space and customer support.

2. WHEN THIS POLICY COMES INTO EFFECT

This Policy applies immediately if you are a new subscriber to the Service. For current subscribers, this Policy applies 14 days after this Policy is posted on Dodo Australia's website. If any changes are made to this policy by Dodo Australia, these changes come into effect 14 days after the revised policy is posted on Dodo Australia's website.

3. SECURITY

3.1 Passwords

You must keep confidential the password you use to subscribe to the Service. You remain responsible for any use of the Service made using your password.

3.2 Unauthorised Access

You must not attempt to obtain unauthorised access to any computer system, including unauthorised access to Dodo Australia's system (for example, by attempting to use the account of another user). You must not host any content that enables others to obtain such access.

3.3. Attacks on Third Party Systems

You must not participate (including by making content available) in any attempt to cause any computer system (including Dodo Australia's system) to malfunction, whether by way of viruses, worms, trojan horses, denial of service attacks or otherwise.

4.ILLEGAL AND INFRINGING USE AND CONTENT

You must not use the Service to breach any applicable criminal laws or to infringe on the rights of a third party. This includes, without limitation:

- fraudulent, deceptive or illegal activity;
- infringement of copyright, trademarks or other intellectual property rights;
- infringement of laws relating to censorship and classification of material;
- using the Service to create, forward or distribute defamatory statements.

5. USE OF THE SERVICE

Use of Dodo Australia's services must:

- comply with all current laws and regulations;
- comply with Dodo Australia's Webhosting Terms and Conditions; and
- comply with Dodo Australia's mail service limits (if any).

6. LIABILITY

You must not use the Service to distribute electronic communications (including electronic mail, SMS messages, chat messages and newsgroup postings):

- to a person or group who has indicated that they do not wish to receive the communication from you;
- if the communication is unsolicited bulk mail (whether or not it is commercial in nature) or is an unsolicited commercial message as defined in the Spam Act 2003;
- in a way that forges or disguises the origin of the communication;
- in a way which is intended, or likely to, adversely affect the functionality of any computer system (including Dodo Australia's systems).

7. CHARGES AND PAYMENT

Where you believe that there has been a potential violation of this Acceptable Use Policy, you may forward any complaints you have to Dodo Australia via email: **support@business.dodo.com.au**.

8. WHAT HAPPENS IF YOU BREACH THIS POLICY

If Dodo Australia reasonably believes on reasonable grounds that you have breached this Policy, Dodo Australia may (but is not obliged to) take one or more of the following steps:

- suspend your access to the Service indefinitely or for a specific period;
- terminate your access to the Service and refuse to provide the Service to you or your associates in the future;
- inform appropriate government and regulatory authorities of suspected illegal or infringing conduct; and
- delete or edit any of your data (including webpage content) stored on Dodo Australia's computer systems.
